l, Addie L. Perkins, of lawful age, being first duly swom on oath, depose and state:

Your Affiant is a Detective with the Wichita Police Department, and in that capacity was assigned the follow-up investigation of Wichita Police Department case 17C014397. This incident occurred on March 3, 2017 at 2354 hours, Wichita, Sedgwick County, Kansas. After reading the reports of the officers involved, your Affiant has learned the following information.

On March 3, 2017, Sedgwick County 911 received multiple calls of a shooting at 1704 South Yale. Dispatch advised AF called and reported that a neighbor, "Fabian", had shot another neighbor. AF advised that the shooting might have been accidental, and that AF currently had the gun that was involved. AF advised that the shooting had occurred inside 1704 South Yale.

Officers arrived on scene, and Officer W. Gray #2518 located AF standing in the driveway south of 1704 South Yale. AF was standing, and talking on a cell phone, and had a holster on his right hip. Officer W. Gray observed a handgun lying on the ground in the driveway at AF's feet. The gun was later determined to be a black Glock semi-automatic handgun, with what appeared to be blood on the back strap.

Officer J. Gray #2390 contacted DNP at 1702 South Yale, the adjoining duplex to 1704 South Yale. DNP invited Officer Gray inside, and stated that she "had something to show him". DNP began calling her brother Fabian Griffin to come upstairs. Officer Gray heard a male voice reply that he did not want to come upstairs because Officers were going to take him to prison. Fabian came upstairs, and came outside with DNP and Officer J. Gray.

DNP later told Detective Manuel #2151 in an interview that she was asleep on the couch in her living room when she was awakened by a loud thump, as if someone had fallen in the apartment next to hers. DNP stated that she knew her brother, Fabian Griffin, and his friends Casey Lawrukiewicz, and AF hung out together in the apartment next to her. DNP stated that the three were very good friends. DNP stated that the loud thump prompted her to go next door to see what was going on. DNP stated that when she went outside she heard her brother Fabian Griffin yelling "No No"! DNP stated that as she went outside she noticed a small hole the size of a bullet hole in the front window at 1704 S. Yale. DNP stated that she touched the glass and it broke. DNP stated that she was met at the door by AF and Fabian. DNP stated that Fabian was yelling "I fucked up". DNP stated that she asked what had happened and Fabian responded that Casey Lawrukiewicz, and he were playing around shooting blanks at each other. Fabian stated that he pointed the gun at Casey and the gun went off.

DNP stated that Fabian then said he was going to kill himself because he had hurt his friend. DNP stated that she took Fabian back to her residence and locked him in the basement so that he would not hurt himself. DNP stated that her girlfriend NH and NH's mother DT were at her residence but left in her green Ford Crown Victoria after the incident. DNP stated that AF told her that Fabian and Casey were shooting blanks and Fabian shot Casey.

Officer Hageman #2548 initially had contact with JF and he was later interviewed by Detective Hicks #2168. JF advised he and his girlfriend, TT, were lying in bed at his residence, 1701 S. Yale, watching TV when they heard one pop that JF stated he knew was a gunshot. JF then heard multiple females screaming "Casey, Casey" from outside his residence. JF said he told TT to call Casey's (nephew) phone and she was unable to get ahold of him. JF then told her to call 911 and ran outside. When he got outside, he saw the front door of 1704 S. Yale was open and the home owner he knows as, AF, was standing outside in the driveway on his phone. JF advised he ran across the street to look for Casey and AF stepped in front of him and told JF not to go inside the house, and that he was on the phone with the police. JF said that he pushed AF out of the way and as he did, AF, using his right arm pointed something in JF's direction and told JF he's on the phone with the cops and not to go inside. JF stated that he couldn't see what the object AF was holding, only that it was small and when he pointed it at him, it made a clicking sound; he believed like a hammer being pulled back on a gun. JF stated he was not scared for his safety and only worried about Casey and he turned and ran into 1704 S. Yale to look for him.

JF advised once inside the residence, he located Casey sitting on the couch in the living room and he was hunched over with blood coming from his mouth. JF said he ran from the residence and went to 1720 S. Yale, where Casey's mother lives, and began to bang on the door, but got no answer. JF stated he ran back to 1704 S. Yale and when he arrived, he saw officers had stopped a vehicle leaving and he began to run toward the officers screaming at them that his nephew has been shot and needed help.

In a post Miranda interview with your Affiant and Detective Tennyson, AF advised he was at his house at 1704 S. Yale with Fabian and Casey. AF said he had his loaded 9mm Glock handgun on his computer desk. AF said as he reached over to grab a charging cable, he heard a single gunshot. AF said he turned around and Fabian dropped the gun to the ground and he observed Casey was on the couch and had been shot. AF said Fabian freaked out and AF picked up the gun, grabbed his phone, and went outside to call 911.

In a post Miranda interview with your Affiant and Detective Tennyson, Fabian Griffin advised he was at his friend AF's house at 1704 S. Yale, with AF and another friend Casey. Fabian stated he knew AF had a Glock handgun that he has previously fired blank rounds of ammunition from. Fabian said he had possession of the gun and thought the gun was loaded with blank rounds and he had it pointed in the direction of Casey. Fabian stated the gun went off and he shot Casey. Fabian said after the shot was fired, AF took the gun from him. Fabian said he was scared and went to his sister's house to kill himself. Fabian said they do "Jackass" type jokes on each other and said at one point someone had possibly videotaped some of the stunts.

Casey was identified as Casey Lawrukiewicz and was found to have marijuana and U.S. Currency on his person. Casey was transported to Wesley by Medic 34, and was later pronounced deceased at 0135 hours on March 4th, 2017 by Dr. Waswick.

A search was completed at 1704 S. Yale and multiple 9mm shell casings were located along with a 9mm Ruger handgun, and blood inside the residence. A Glock 9mm handgun was located in a driveway.

Fabian Griffin was convicted in 3rd Judicial District Court of Kansas in Shawnee County under case number 06CR001930, for Aggravated Weapons Violation, contrary to K.S.A. 21-4201(a)(1-5) or (a)(9), a severity level 9, non-person felony, on May 10, 2007. Fabian Griffin was also convicted in the 3rd Judicial District Court of Kansas in Shawnee County under case number 94CR2791, for Attempted Robbery, pursuant to K.S.A. 21-3426, a severity level 7, person felony, on February 24, 1995.
